## UPS International Ground Export Import Fuel Surcharge

UPS uses an index-based surcharge that is adjusted weekly. Changes to the surcharge will be effective on Monday of each week. The surcharge will be based on the National U.S. Average On-Highway Diesel Fuel Price as most recently released by the U.S. Energy Information Administration (EIA) rounded to the nearest cent. For example, the surcharge for the week of May 5, 2025 is based on the National U.S. Average On-Highway Diesel Fuel Price released by the EIA the week of April 28, 2025.

# UPS International Air-Export and International Air-Import Fuel Surcharge

UPS uses an index-based surcharge that is adjusted weekly. Changes to the surcharge will be effective on Monday of each week. The surcharge will be based on U.S. Gulf Coast (USGC) price for kerosenetype jet fuel as most recently released by the U.S. Energy Information Administration (EIA) rounded to the nearest cent. For example, the surcharge for the week of May 5, 2025 is based on the U.S. Gulf Coast (USGC) price for kerosene-type jet fuel released by the EIA the week of April 28, 2025.



### **Services Affected**

The International Ground Export Import Fuel Surcharge will apply to charges for the following services:

UPS® Standard to/from Canada and UPS® Standard to/from Mexico

The International Air-Export and International Air-Import Fuel Surcharge will apply to charges for the following services:

UPS 3 Day Select<sup>®</sup> from Canada, UPS Worldwide Express Plus<sup>®</sup>, UPS Worldwide Express NA1<sup>®</sup>, UPS Worldwide Express<sup>®</sup>, UPS Worldwide Express Freight<sup>®</sup> Midday, UPS Worldwide Express Freight<sup>®</sup>, UPS Worldwide Saver<sup>®</sup>, UPS Worldwide Expedited<sup>®</sup>, and UPS Express Critical<sup>®</sup>.

Fuel surcharges apply to all domestic and international transportation charges and certain other accessorial charges, value added charges, surcharges and other charges.
