An Address Correction charge will be assessed to the shipper for an address correction or completion.

Hazardous Materials packages requiring shipping papers as described under Title 49 C.F.R. Section 172.200 are not accepted in any UPS Hundredweight Service shipment. In addition, Limited Quantities (Ltd Qty) shipments are prohibited in all UPS Hundredweight Services shipments.

UPS Express® Envelopes are excluded from UPS Hundredweight Service shipping.

UPS Hundredweight Service rates are effective December 26, 2023 (unless otherwise noted).

UPS reserves the right, in its sole discretion, to use any mode of transportation whatsoever to provide the service selected by the shipper.
